In December 2021, the Center for International Forestry Research (CIFOR) and World Agroforestry (ICRAF) completed a three-year programmatic and operational merger process. The functional merger brings together more than 70 years of combined expertise, over 700 staff working in 60 countries across the Global South, offices in 25 countries, 14 host country agreements, nearly 200 active partnerships, and intellectual assets published in some 25,000 research products.
