The Securities and Exchange Commission (SEC) is a body corporate established under the Securities Act Cap. 354 of the Laws of Zambia and whose functions are set out in the Securities Act No. 41 of 2016 to regulate and promote the Capital Markets. SEC is responsible for inter alia licensing of securities and derivatives exchanges, the registration of securities such as instruments and authorisation of collective investment schemes.

SEC has allocated funds in its 2023 budget for procurement of Two (2) fully redundant servers to host its Supervisory Technology (SupTech) platform.

C intends to engage the services of an experienced information technology firm to supply and install two (2) servers at its production and disaster recovery (DR) sites.

Supplier will be expected to provide the following services:

• Configuration of one (1) HPE Gen10 Server, SAN storage and network equipment at production site;

• Configuration of one (1) HPE Gen10 Server, SAN storage and network equipment at disaster recovery (DR) site;

• Configuration VMware software for virtualization at production site;

• Configuration VMware software for daily backup of the virtual environment;

• Configuration of Veeam software for site recovery.

Qualifications of service providers from IT firms to provide the services listed above.
